



SNSports Terms of Service

Updated 2/26/2026

1. Overview

SNSports is a sports card consignment service facilitating the auction sale of trading cards. By submitting cards or using SNSports services, you agree to these Terms of Service.

2. Auction & Listing Format

All cards are listed starting at \$0.99 auction. Listings generally occur within 4–6 business days after receipt. Express Upgrade is available for cards reasonably expected to sell for \$100 or more at \$2 per card, in addition to the standard \$1 per card selling fee, for 1–2 business day listing turnaround. SNSports retains sole discretion over listing format and scheduling.

3. Zero-Bid Policy

Cards receiving no bids at \$0.99 become property of SNSports and will not be returned.

4. Non-Paying Buyers

If a buyer fails to pay within 7 days, the item will be relisted without additional listing charge to the consignor.

5. Payout Structure

Payout percentages follow the posted SNSports payout chart. Payouts are issued via PayPal after buyer payment clears and applicable return windows expire. The payout structure in effect at time of receipt applies to that submission.

6. Chargeback & Return Protection

Once payout has been issued, if a buyer later forces a return, dispute, or chargeback, ownership of the returned item transfers to SNSports. The consignor will not be required to return previously paid funds.

7. Shipping & Insurance

SNSports is not responsible for items lost, stolen, or damaged in transit prior to delivery at our facility. Consignors are responsible for properly packaging and insuring shipments sent to SNSports.

8. Service Suitability

This service is best suited for cards valued at \$5 or more. Excessive bulk base or low-value submissions may be rejected.

9. Rejected Items

SNSports reserves the right to reject any submission or individual item. Return shipping for rejected items may be paid by the consignor or deducted from sale proceeds.

10. Fees

A \$1 per card selling fee applies to all submitted items. The optional Express Upgrade is \$2 per qualifying card and is charged in addition to the standard \$1 fee.

11. Limitation of Liability

SNSports is not liable for market fluctuations, auction outcomes, platform outages, buyer fraud beyond our control, postal delays, or grading variances.

12. Force Majeure

SNSports shall not be held liable for delays or failure to perform resulting from causes beyond reasonable control, including natural disasters, postal interruptions, platform outages, governmental actions, or other unforeseen events.

13. Governing Law

These Terms of Service are governed by and construed in accordance with the laws of the State of Ohio. Any disputes shall be resolved in courts located within the State of Ohio.

14. Modification of Terms

SNSports reserves the right to modify these Terms at any time. Updated Terms apply to future submissions and continued use of services constitutes acceptance.

15. Right to Refuse Service

SNSports reserves the right to refuse service, decline submissions, terminate relationships, or update policies at its sole discretion.

16. Agreement

Submission of cards to SNSports constitutes acknowledgment and acceptance of these Terms of Service.
